### ERG Support for ACLCA

While ERG's EPD Quality Label Program will initially leverage existing standards for PCRs, in the future we plan to align with ACLCA's forthcoming PCR Open Standard Version 2. ERG is assisting ACLCA in the development of this revised standard, leveraging our staff's expertise and first-hand knowledge from creating EPA's PCR Criteria and EPA's Framework for the Assessment of Environmental Performance Standards and Ecolabels for Federal Purchasing. We are designing our program intentionally to be collaborative and to coordinate with ACLCA to develop high-quality standards through a rigorous, multi-stakeholder consensus-based process.
